## **PUBLIC NOTICE**

### **Two Applicants Compete for Acute Care Beds and Operating Rooms in Mecklenburg County**

RALEIGH — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop acute care beds and operating rooms in Mecklenburg County. The applicants propose a total of eight projects.

#### **Novant Health proposes two projects:**

- Novant Health Matthews Medical Center proposes to develop one additional operating room at its hospital in Matthews. The project is expected to cost \$2.2 million and would be completed in July 2023.
- Novant Health Matthews Medical Center proposes to develop 20 additional acute care beds at its hospital in Matthews. The project is expected to cost \$27.2 million and would be completed in July 2023.

#### **Atrium Health proposes six projects:**

- The Charlotte-Mecklenburg Hospital Authority proposes to develop a satellite hospital campus of Atrium Health University City in Cornelius with 30 acute care beds and two operating rooms called Atrium Health Lake Norman. The project is expected to cost \$147 million and would be completed in January 2023.
- Atrium Health University City proposes to develop 16 additional acute care beds at its hospital in Charlotte. The project is expected to cost \$3.8 million and would be completed in April 2021.
- Carolinas Medical Center proposes to develop 18 additional acute care beds at its hospital in Charlotte. The project is expected to cost \$10.5 million and would be completed in July 2021.
- Carolinas Medical Center proposes to develop two additional operating rooms at its hospital in Charlotte. The project is expected to cost \$8 million and would be completed in July 2021.
- Atrium Health Pineville proposes to develop 12 additional acute care beds at its hospital in Charlotte. The project is expected to cost \$7.2 million and would be completed in January 2022.
- Atrium Health Pineville also proposes to develop two additional operating rooms at its hospital in Charlotte. The project is expected to cost \$15.7 million and would be completed in August 2022.
