COMMENTS IN OPPOSITION FROM NOVANT HEALTH, INC.

Regarding OrthoCarolina and Compass Surgical Partner's Triad Center for Surgery CON Application, Project I.D. # G-011513-18 to Develop 2 ORs in Forsyth County

INTRODUCTION

The 2018 State Medical Facilities Plan ("SMFP") shows a need for four additional operating rooms ("ORs") in Forsyth County. In response to the published need Novant Health filed two applications for two ORs each at Novant Health Forsyth Medical Center ("NHFMC") and at the Novant Health Clemmons Outpatient Surgery, LLC ("NHCOS"). These applications were assigned Project I.D. Numbers G-011517-18 and G-011518-18 respectively.

Three applications were filed by other providers:

- North Carolina Baptist Hospital ("NCBH") applied to add four shared ORs in Ardmore Tower Project I.D. # G-011519-18.
- MC Kernersville, LLC and Moses Cone Memorial Hospital ("MCMH") applied to construct a new ambulatory surgical facility ("ASF") with two ORs and a Gastrointestinal Endoscopy Room on its outpatient campus in Kernersville Project I.D. # G-011516-18.
- OrthoCarolina physicians and Compass Surgical Partners ("OrthoCarolina")
 applied to renovate space for two ORs in Winston-Salem in the space now
 occupied by the Novant Health Orthopedic Outpatient Surgery Center Project
 I.D. # G-11513-18.

Because the Agency can approve no more than four new ORs, the five applications are subject to competitive review. As part of the competitive review process, Novant Health files these comments on the three competing application to show the Novant Health applications better meet the surgical needs of Forsyth County and the goals of the CON program. Nothing in these comments is intended to amend or modify the two Novant Health applications.

EXISTING SURGICAL AND ENDOSCOPY FACILITIES

The existing and approved surgical facilities in Forsyth County and in the adjacent Counties of Davie and Guilford are part of the context in which the Agency must compare the five applications. Attachment 1 shows information on each existing and approved surgical facility. Attachment 2 shows information on each GI endoscopy room. The facilities in adjacent

counties are relevant because the service areas for Kernersville and for Clemmons extend into the adjacent county.

Novant Health notes that all its approved surgical projects are open or are under construction and on schedule to open as planned in 2019. Novant Health also notes ORs relocated to the recently-opened Novant Health Kernersville Outpatient Surgery ("NHKOS") are paid by Medicare and other payors as freestanding ambulatory surgery centers and not as hospital outpatient departments. The same will be true for Novant Health Clemmons Outpatient Surgery ("NHCOS") when it opens in 2019.

THE NHCOS APPLICATION IS LESS COSTLY AND MORE EFFECTIVE THAN ORTHOCAROLINA'S APPLICATION

Criterion (4) requires the applicant to propose the least costly or most effective alternative. Ortho Carolina's proposal satisfies neither part of Criterion (4).

In a competitive review, Novant Health's application to add two ORs to Novant Health Clemmons Outpatient Surgery, LLC (NHCOS) is superior to the Triad Center for Surgery application of OrthoCarolina and Compass Surgical Partners to renovate the space currently leased by Novant Health Orthopedic Outpatient Surgery (NHOOS) for two ORs and three procedure rooms. The Novant Health application is superior in these ways.

- The project cost is less
- The Novant Health ORs will be placed in service sooner
- The Novant Health project will provide more benefits to underserved populations
- As a multi-specialty ASF, the four OR NHCOS is a more flexible and cost effective alternative than the OrthoCarolina proposal

Project Cost. The cost to add two ORs in facilities paid as ASFs by Medicare is \$3.1 million for the Novant Health application and \$7.2 million for the OrthoCarolina application. ¹ Both are finishing out space in existing structures. An important reason for the difference in cost is the support spaces for the Novant Health ORs were part of the costs already incurred for NHCOS. Another reason is the Novant Health ORs will be in a new structure that meets all current building and life safety code requirements. OrthoCarolina must bring 14,700 square feet of older space up to current code requirements. The Novant Health application supplies two of the ORs needed in Forsyth County more economically than OrthoCarolina. ²

In Service Date. The first two ORs at NHCOS will be placed in service on July 1, 2019. As reflected in the projections for NHCOS in Project I.D. #G-11300-17, outpatient surgical volume from Novant Health Orthopedic Outpatient Surgery ("NHOOS") is expected to shift to NHCOS when NHOOS closes and NHCOS opens in July 2019.³ Novant Health's lease at 180 Kimel Park extends to January 31, 2020. Assuming the current NHCOS application is approved and there is no appeal, the additional two ORs at NHCOS will be in service on April 1, 2020. The additional two ORs can be finished and equipped without disrupting surgeries and other procedures at NHCOS. The OrthoCarolina ORs will not be in service until January 1, 2021.⁴

OrthoCarolina was consulted in the fall of 2016 about the possible relocation of the NHOOS ORs to NHCOS. Because about half the OrthoCarolina physicians who perform surgery at 180 Kimel Park live in the Clemmons area and because more of their patients come from the Clemmons zip code 27012 than any other, OrthoCarolina physicians supported the NHCOS application. Drs. Daniel Biggerstaff, William L. Craig, III, David V. Janeway, Michael Lauffenburger and John E. Ritchie wrote letters of support. With NHCOS under construction and scheduled to open in July 2019, their support for a competing application in which some have an ownership interest undermines a state-approved project.

Benefits to Underserved Populations. The Novant Health application will provide more benefits to self-pay, charity care and Medicaid patients than the OrthoCarolina application. The table below compares the payor mix in the two applications. Some variation reflects the mix of specialties. For instance, a higher percentage of ophthalmic procedures tends to increase the Medicare percentage. The self-pay, charity care and Medicaid are usually considered the underserved populations. NHCOS projects serving 6.80% of patients compared to OrthoCarolina's 5.39%.

OrthoCarolina has not always met its commitments for services to underserved populations. In Mecklenburg County, OrthoCarolina was approved for a single specialty ambulatory surgery facility demonstration project called University Surgery Center (dba Mallard Creek Surgery Center). As outlined in the 2010 State Medical Facilities Plan, the demonstration project required that the percentage of the facility's total collected revenue that is attributed to self-pay and Medicaid revenue shall be at least seven percent. OrthoCarolina was unable to meet the requirement and in July 2017 petitioned the State Health Coordinating Council to reduce the requirement to five percent and change the calculation to be easier to meet. Novant Health opposed the petition because OrthoCarolina did not show a diligent effort to meet the requirement. Ultimately, the request to reduce the percentage of revenue attributable to self-pay and Medicaid from 7% to 5% was denied and the calculation was modified to exclude the revenue from procedures that do not yet have a Medicare allowable amount or are not currently ASF approved by Medicare from the denominator.

OrthoCarolina has no meaningful charity care policy. The OrthoCarolina policy gives no assurance it will provide any charity care or discounts. The two page document included with the exhibits to the application indicate the decision to provide charitable care shall be made on a case-by case basis by the administrator with no criteria for evaluating requests for charity care. ¹¹ The contrast with Novant Health's charity and financial assistance polices is stark. Novant Health determines eligibility for discounts and free care based on household income and patient responsibility if insured. ¹² The charity care policies are Attachment 3 to this letter.

Since all surgeries at an ASF are non-emergent scheduled procedures, there are no unfunded patients unless the physician first agrees to donate his or her services. The medical staff of NHCOS includes physicians employed by Novant Health whose services are covered by the same Novant Health charity care policy as the facility. This arrangement gives the State greater assurance underserved patients in need of non-emergent surgery will receive it.

ASF Economies of Scale. Expanding NHCOS to a four-OR ASF is more cost effective than two two-OR ASFs. A multi-specialty ASF with two ORs can operate efficiently and increase surgeon productivity compared to mixed use ORs in hospitals. However, if the population base and physician support is sufficient to support four ORs in the ASF even greater efficiencies become possible. Where there is substantial overlap between medical staffs and

service areas as here, one four-OR ASF is preferable to two two-OR ASFs. There are economies of scale in:

- front office and back office support staff
- operating room equipment
- supply inventories
- ability to provide surgeons with multi-room block time
- utilities, maintenance and other facility operating expenses

Approval of the NHCOS application will lead to more cost-effective care than approval of the OrthoCarolina ASF.

For all the reasons in this comment, Novant Health respectfully requests the State to approve the NHCOS 2018 application for two multi-specialty outpatient ORs and deny the OrthoCarolina (Triad Center for Surgery) application for two multi-specialty outpatient ORs.
