### Two Compete for Inpatient Rehabilitation Beds in Mecklenburg County

RALEIGH — Two competing certificate of need applications have been filed with the North Carolina Department of Health and Human Services to develop eight inpatient rehabilitation beds in Mecklenburg County.

The proposals are as follows:

- Carolinas Rehabilitation in Charlotte proposes to develop eight new inpatient rehabilitation beds. The project is expected to cost \$234,000 and would be completed in July 2019.
- Novant Health Presbyterian Medical Center in Charlotte proposes to develop eight new inpatient rehabilitation beds. The project is expected to cost \$2.1 million and would be completed in January 2021.

A public hearing for these projects will be held Nov. 14 at 11 a.m. in meeting room 280 of the Charlotte-Mecklenburg Government Center, 600 E. Fourth St., Charlotte.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5:30 p.m. on Oct. 31.
