## **PUBLIC NOTICE**

### **Two Hospital Systems Compete for Acute Care Beds in Mecklenburg County**

**CHARLOTTE, N.C.** — Two hospital systems have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop acute care beds in response to a need determination in the 2023 State Medical Facilities Plan for 164 acute care beds in Mecklenburg County. The two hospital systems propose a total of four projects.

Atrium Health proposes three projects:

- Carolinas Medical Center proposes to develop 112 additional acute care beds at its existing hospital in Charlotte. The project is expected to cost \$161.3 million and would be completed in April 2027.
- Atrium Health University City proposes to develop 10 additional acute care beds at its existing hospital in Charlotte. The project is expected to cost \$7.1 million and would be completed in June 2025.
- Atrium Health Pineville proposes to develop 42 additional acute care beds at its existing hospital in Pineville. The project is expected to cost \$30.9 million and would be completed in July 2025.

Novant Health proposes one project:

- Novant Health Presbyterian Medical Center proposes to develop 54 additional acute care beds at its existing hospital in Charlotte. The project is expected to cost \$1 million and would be completed in July 2025.

A public hearing for these projects will be held Dec. 15 at 1:30 p.m. in room 280 of the Charlotte-Mecklenburg Government Center, 600 E. Fourth St. in Charlotte.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Dec. 1.
