PUBLIC NOTICE

Two Applicants Compete for Acute Care Beds in Durham County

RALEIGH — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop 38 acute care beds in Durham County pursuant to the need determination in the 2024 State Medical Facilities Plan.

The applicants propose two projects:

- University of North Carolina Hospitals at Chapel Hill and the University of North Carolina Health Care System propose a cost overrun and change of scope to develop 38 additional acute care beds at a proposed new hospital in Durham — UNC Hospitals-RTP — for a total of 112 acute care beds. The project is expected to cost \$371.3 million and would be completed in July 2032.
- Duke University Health System Inc. proposes to develop 38 additional acute care beds at Duke University Hospital for a total of 1,100 acute care beds. The project is expected to cost \$4.8 million and would be completed in January 2025.

A public hearing for these projects will be held June 19 at 11 a.m. in the Edgerton Building, room 26, on the Dorothea Dix Campus, 809 Ruggles Drive in Raleigh.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on May 31.
