Three Applicants Compete to Develop Hospice Home Care Office in Cumberland County

FAYETTEVILLE, N.C. — Three applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop a hospice home care office in response to a need determination in the 2025 State Medical Facilities Plan for one hospice home care office in Cumberland County.

Each applicant proposes one project:

Hospice & Palliative Care Charlotte Region proposes to:

- Develop a hospice home care office pursuant to the 2025 SMFP need determination. The project is expected to cost \$85,000 and would be completed in April 2026.

VITAS Healthcare Corporation of North Carolina and VITAS Healthcare Corporation propose to:

- Develop a hospice home care office pursuant to the 2025 SMFP need determination. The project is expected to cost \$278,300 and would be completed in July 2026.

Well Care Hospice of Cumberland, Inc. proposes to:

- Develop a hospice home care office pursuant to the 2025 SMFP need determination. The project is expected to cost \$100,000 and would be completed in October 2026.

A public hearing for these projects will be held April 16 at 11 a.m. in the Meeting/Activity Room (CLF) of the Cliffdale Regional Branch Library, 6882 Cliffdale Road in Fayetteville.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on March 31.
