
Dear Mr. Bradshaw:

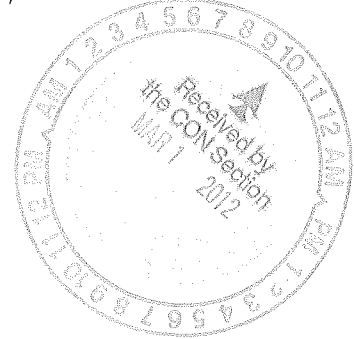

RE: Wayne Memorial Hospital's Exemption Request for a Medical Office Building

Dear Mr. Smith:

Wayne Memorial Hospital (WMH), a hospital in Goldsboro, North Carolina, intends to construct a Medical Office Building (MOB) on WMH's existing campus approximately 100 yards from the hospital building. Current plans for the MOB include space for physician offices, specifically Wayne Health Physicians, an employed physician group and sister company to Wayne Memorial Hospital, Inc. The services to be provided relative to these physician offices constitute components of a physician practice and not components of a licensed health service facility and thus are exempt from review under N.C. GEN. STAT. § 131E-184(a)(9).

While the majority of the building will house physician offices, please note that WMH currently plans to relocate one hospital-provided service to the building. As such, concurrent with the submission of this Exemption Request, WMH is filing a No Review Request for confirmation that the relocation of the hospital-based service, specifically, a diabetes education center, in a portion of the MOB is not subject to CON review.

Based upon the project as described above and pursuant to N.C. GEN. STAT. § 131E-184(a)(9), this letter serves as notification of our intent to proceed with this project. We would appreciate your written confirmation that the development of the MOB, other than the hospital-based service addressed in the concurrently filed No Review Request, is exempt from CON review.
