Dear Mr. Hemphill:

In response to your letter of May 17, 2013, the acquisition of the wing owned by Duplin General Hospital by The Kornegay Company, LLC is exempt from certificate of need review in accordance with N.C.G.S 131E-184(a)(8). Therefore, The Kornegay Company, LLC may proceed to acquire the wing owned by Duplin General Hospital in the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Nursing Home Section of the Division of Health Service Regulation to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C.G.S. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Dear Ms. Frisone and Ms. Quirin:

We are writing you on behalf of our client, The Kornegay Company, LLC ("Kornegay"), a North Carolina limited liability company, requesting the CON Section to issue, pursuant to G.S. §131E-184(a)(8), a letter determining that Kornegay's anticipated acquisition of the building housing a wing of the above nursing facility is exempt from certificate of need review, within the meaning of the certificate of need law.

The background regarding this transaction is as follows. On October 15, 2011, Kornegay, Duplin General Hospital and Kornegay Healthcare, Inc. filed a CON application (Project I.D. No. P-8728-11) to relocate 20 nursing facility beds from DGH, into a wing of the GlenCare of Warsaw (now known as Warsaw Health and Rehabilitation) facility. As set forth on page 1 of the Agency's December 2, 2011 Required State Agency Findings approving the application:

Kornegay Company, LLC (Lessor) and Duplin General Hospital, Inc. (Lessee) propose to transfer 20 nursing facility beds from Duplin General Hospital to a wing in Glencare



¹ At the time of the application, Kornegay Healthcare, Inc. was the Facility lessee. Since that time, Kornegay Healthcare, Inc. has been replaced as lessee by Sovran Senior Living, LLC ("Sovran"). The Agency was notified of this change, and the CON issued for the project included Sovran as the Facility lessee. See *Exhibit A* hereto.

(known as the DGH Wing) and lease the land to Duplin General Hospital pursuant to a ground lease. Duplin General Hospital will sublease the DGH wing to Glencare. Kornegay Healthcare Inc. will eliminate 26 existing ACH beds in order to accommodate the transfer of the 20 nursing facility beds from Duplin General Hospital. Kornegay Healthcare Inc. will operate the entire Glencare facility including the DGH wing as a 100-bed nursing facility. The applicants assume that after the project is complete, Duplin General Hospital will transfer all its interests in the nursing facility beds, the ground lease will be terminated and Kornegay will lease the entire Glencare of Warsaw facility directly to Glencare.

The beds in the DGH Wing have now been certified as part of the facility, as reflected in the letter and license issued by the N.C. Department of Health and Human Services, Division of Health Service Regulation, Nursing Home Licensure and Certification Section, attached hereto as *Exhibit B*. The parties are prepared to move forward with the transaction. Duplin General Hospital, Sovran and Kornegay have entered into an Asset Purchase Agreement, whereby Kornegay will acquire Duplin General Hospital's interest in the DGH Wing, contingent upon Agency approval. Thereafter, Kornegay will own the entire facility, and directly lease the facility to Sovran as the operator/lessee.

By this letter, we are providing notice to the CON Section, pursuant to G.S. §131E-184(a). Because this project involves the acquisition of an existing health service facility, we believe that Kornegay's acquisition of the DGH Wing is exempt from CON review pursuant to G.S. §131E-184(a)(8). We would appreciate your office reviewing this information and advising us that our analysis is correct and that this acquisition is not subject to CON review.

Stat. § 131E-175, et. seg.; the North Carolina Department of Health and Human Services hereby authorizes the person of persons named above (the "certificate holder") to develop the certificate of need project identified above. The certificate holder shall develop the project in a manner consistent with the representations in the project application and with the conditions contained herein and shall make good faith efforts to meet the timetable contained herein. The certificate holder shall not exceed the maximum capital expenditure amount specified herein during the development of this project, except as provided by N.C. Gen. Stat. § 131E-176(16)e. The certificate holder shall not transfer or assign this certificate to any other person except as provided in N.C. Gen. Stat. § 131E-189(c). This certificate is valid only for the scope, physical location, and person(s) described herein. The Department may withdraw this certificate pursuant to N.C. Gen. Stat. § 131E-189 for any of the reasons provided in that law.

SCOPE: Duplin General Hospital, Inc., The Kornegay Company LIC; and Sovran Senior Living, IIC shall relocate the 20 nursing facility beds at Duplin General Hospital to Warsaw Health and Rehabilitation (formerly Glen are of Warsaw) for a total of no more than 100 nursing facility beds and no adult care home beds at Warsaw Health and Rehabilitation upon project completion/Duplin County

CONDITIONS:

- 1. Duplin General Hospital, Inc., The Kornegay Company, LLC and Sovran Senior Living, LLC shall materially comply with all representations made in the certificate of need application and in the supplemental materials dated April 18, 2012. In those instances where representations conflict, Duplin General Hospital, Inc., Kornegay Healthcare, Inc. and Sovran Senior Living, LLC shall comply with the later representation.
- 2. Duplin General Hospital, Inc. shall relocate the 20 existing nursing facility beds at Duplin General Hospital to Warsaw Health and Rehabilitation (formerly GlenCare of Warsaw).
- 3. Upon licensure of the 20 nursing facility beds at Warsaw Health and Rehabilitation, Duplin General Hospital shall take the necessary steps to de-license the 20 nursing facility beds on the hospital's license.
- 4. Upon project completion, Warsaw Health and Rehabilitation shall be licensed for no more than 100 nursing facility beds and no adult care home beds.
- 5. The Kornegay Company, LLC and Sovran Senior Living, LLC shall submit all patient charges and actual per diem reimbursement rates for each source of patient payment to the CON Section at year end for each of the first two operating years following licensure of the beds at Warsaw Health and Rehabilitation.
- 6. The Kornegay Company, LLC and Sovran Senior Living, LLC shall receive the Medicaid per diem reimbursement rates allowed by the Division of Medical Assistance, under the NC State Plan Section .0102.
- 7. For the first two full federal fiscal years of operation following completion of the project, actual private pay charges shall not be increased more than 5% of the projected private pay charges provided in Section X of the application without first obtaining a determination from the Certificate of Need Section that the proposed increase is in material compliance with the representations in the certificate of need application.
