

Dear Ms. Frisone:

Pinehurst Medical Clinic, Inc requests a No Review Determination from the Certificate of Need Section for a new physician office location to be established at 1409 Greenway Court in Sanford, North Carolina. This new physician office location will allow for the relocation of existing diagnostic equipment from our satellite office in Sanford, Sanford Cardiology and Pulmonology Medicine (formerly Sanford Cardiology, PLLC. Sanford Cardiology, PLLC was merged out of existence May 11, 2011 and into Pinehurst Medical Clinic, Inc.) at 110 Fields Drive, with a total capital cost of substantially less than \$500,000. The diagnostic equipment to be relocated includes the pulmonary function testing (PFT) equipment, arterial blood gas (ABG) equipment and sleep center equipment that is listed in Attachment 1 with the manufacturer, model, and original purchase costs. This equipment will be utilized at the new physician office location in support of the pulmonology practice.

Sanford Cardiology and Pulmonology at 110 Fields Drive in Sanford, NC is the current physical location of the pulmonary equipment requested to be relocated. In 2009, Sanford Cardiology, PLLC, now Pinehurst Medical Clinic, Inc. obtained Certificate of Need approval to establish a Diagnostic Center at this location with the acquisition of one 3-D ultrasound unit (CON Project ID # J-8350-09 and FID #090424). This office location at 110 Fields Drive in Sanford will continue to hold its designation as a Diagnostic Center and will continue to provide a broad range of cardiology procedures with the existing diagnostic equipment including the existing ultrasound equipment, nuclear camera, and stress test system. In summary, the pulmonary equipment will be relocated to the new physician office location at 1409 Greenway Court in Sanford, N.C. and the cardiology equipment will remain at the Diagnostic Center at 110 Fields Drive in Sanford, N.C.

This letter provides justification and written notice regarding the development of the physician office and the relocation of diagnostic equipment in accordance with GS 131E-184 (a) (9) To develop or acquire a physician office building regardless of cost, unless a new institutional health service other than defined in G.S. 131E-176(16)b is offered or developed in the building.

Compliance with this exemption is documented because none of the diagnostic equipment to be relocated to 1409 Greenway Court is included in the list of equipment provided in G.S. 131E-176 (16) fl or G.S. 131E-176 (16) p. Furthermore the proposed physician office will not be considered a "Diagnostic Center" as defined in G.S. 131E-176 (7a) because the total combined cost of all the medical diagnostic equipment utilized in the physician office which costs \$10,000 or more will not exceed the \$500,000 threshold. As seen in Attachment 1, the total capital cost is based on the original purchase costs of all the equipment, plus the cost to relocate and install the equipment plus all activities required to make the equipment operational.

Pinehurst Medical Clinic plans to occupy the new office location and relocate the equipment in August 2014. Please provide written confirmation that the proposed development of the new physician office at 1409 Greenway Court in Sanford, which includes the relocation of specified diagnostic equipment, is exempt from Certificate of Need review.
