Dear Ms. Jordan:

The Certificate of Need Section (CON Section) received your letter of February 18, 2014 regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Certificate of Need Section. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

RE: No Review Request for Software Acquisition

Dear Ms. Frisone and Ms. Inman:

High Point Regional Health ("HPR UNC") is requesting a "No Review" determination that its acquisition of three software modules is not reviewable as a new institutional health service under the North Carolina Certificate of Need ("CON") law, or otherwise triggers CON review. The software modules ("Software Acquisition") will be used in conjunction with the BioSense Webster's Carto Unit ("EP Equipment"), which provides electrophysiology services to patients at HPR UNC.

The EP Equipment was installed in 2000 and was replaced in 2010. Since that time, significant technological and delivery of care advancements have been made. As a result, the EP Equipment does not afford patients the advanced capabilities that are now available. Several important capabilities are lacking, including the ability to integrate and transmit 3-D images in real time, and enhanced mapping and diagnostic capabilities. The Software Acquisition will allow for advanced integration of mapping with fluoroscopy, improving operational capabilities and shortening procedure times.

The total cost of the proposed Software Acquisition is \$185,000.00. See Exhibit 1, Price Quotation. There are no additional costs associated with the Software Acquisition as listed in N.C. Gen. Stat. § 131E-176(16)b, including the "cost of any studies, surveys, designs, plans, working drawings, specifications, and other activities, including staff effort and consulting and other services, essential to the" Software Acquisition.

The proposed Software Acquisition does not trigger any of the definitions of a "new institutional health service," which implicates CON review. N.C. Gen. Stat. § 131E-178 provides that no person shall offer or develop a "new institutional health service" without

first obtaining a CON. The term "new institutional health service" is defined in over fifteen different ways at N.C. Gen. Stat. § 131E-176(16). Among these definitions is N.C. Gen. Stat. § 131E-176(16)b, which defines a "new institutional health service" to include:

[T]he obligation by any person of a capital expenditure exceeding two million dollars (\$2,000,000) to develop or expand a health service or a health service facility, or which relates to the provision of a health service. The cost of any studies, surveys, designs, plans, working drawings, specifications, and other activities, including staff effort and consulting and other services, essential to the acquisition, improvement, expansion, or replacement of any plant or equipment with respect to which an expenditure is made shall be included in determining if the expenditure exceeds two million dollars (\$2,000,000).

See N.C. Gen. Stat. § 131E-176(16)b.

The proposed Software Acquisition does not constitute a "new institutional health service" under N.C. Gen. Stat. § 131E-176(16)b because the proposal does not exceed the \$2,000,000 threshold. Moreover, the equipment to be acquired is not *per se* reviewable pursuant to the CON statutory scheme, does not result in the development of a "diagnostic center" under N.C. Gen. Stat. § 131E-176(7a), and is not "major medical equipment" under N.C. Gen. Stat. § 131E-176(14o). Because a CON was not required for the acquisition of the EP Equipment and because the EP Equipment was installed more than a year ago, the acquisition is not "a change in a project" under N.C. Gen. Stat. § 131E-176(16)e. Accordingly, the proposed software upgrade does not require HPR UNC to obtain a CON pursuant to N.C. Gen. Stat. § 131E-176(16)b, or any other provision of the CON statutes.

Based upon the foregoing information and the attached document, HPR UNC hereby requests that the Agency provide a written response confirming that the Software Acquisition described herein does not require a CON pursuant to N.C. Gen. Stat. § 131E-176(16)b, or any other provision of the CON statutes. In addition, we respectfully request that this request be considered on an **expedited basis** because HPR UNC wishes to proceed with the Software Acquisition as soon as possible.


