Dear Mr. Gray:

In response to your letter of December 5, 2013, the above referenced proposal is exempt from certificate of need review in accordance with N.C.G.S 131E-184(a)(8). Therefore, Madison Health and Rehabilitation, LLC may proceed to acquire the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Nursing Home Licensure and Certification Section of the Division of Health Service Regulation to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C.G.S. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Notice Pursuant to N.C.G.S. §131E-184(a)(8) of Exempt Acquisition of Existing

Health Service Facility

Dear Mr. Smith and Ms. Halatek:

Madison Health and Rehabilitation, LLC, a North Carolina Limited Liability Company ("MHR"), plans to acquire a 100 bed adult care facility located at 345 Manor Road, Mars Hill, Madison County, North Carolina, currently known as Madison Health & Rehabilitation (the "Facility"). We write now to provide notice of the planned acquisition, which is exempt from certificate of need ("CON") review, to the North Carolina Department of Health and Human Services, Division of Health Regulation, Certificate of Need section (the "Agency").

Madison County (the "County") currently owns the Facility, which is an existing "health service facility," as that term is defined in N.C.G.S. §131E-176(9b). The County intends to transfer 100% of its ownership interest in the facility to MHR. As such, N.C.G.S. §131E-184(a)(8) exempts the transaction from CON review. In addition, MHR's acquisition of the facility does not entail the purchase of any major medical equipment or any *per se* reviewable

equipment, or the offering of any per se reviewable services. N.C.G.S. §131E-176(14)(0), (16)(f), & (16)(f1).

Therefore, we hereby request that the Agency confirm that the above-described proposal is exempt from CON review pursuant to N.C.G.S. §131E-184(a)(8). If you require additional information to consider this request, please contact us at the above number as soon as possible. We thank you for your consideration of this request.
