

Re: Exemption Notice for Alexander Hospital Investors, LLC

Dear Mr. Smith:

The purpose of this letter is to provide notice to the North Carolina Department of Health and Human Services, Division of Health Service Regulation, Certificate of Need Section (the "CON Section") of the acquisition by Charles Trefzger ("Mr. Trefzger") of the membership interests of other members in Alexander Hospital Investors, LLC ("AHI"), an acute care hospital located in Alexander County. Mr. Trefzger currently owns a 19.2308% membership interest in AHI, and will acquire the remaining 80.7692% membership interest so as to own AHI completely. To the extent such acquisition requires a notice of exemption from certificate of need ("CON") review under N.C. Gen. Stat. § 131E-184(a)(8), this letter provides that notification.

I. THE PROPOSAL

In mid-December, Mr. Trefzger will become the sole member of AHI through the acquisition of 80.7692% of the membership interests. The current owners of AHI are listed in Exhibit A by percentage of ownership. Mr. Trefzger seeks confirmation that he is permitted to acquire the membership interests in AHI as described herein without CON Review and that AHI's existing CON rights to own that existing health service facility (as defined in the CON statute) will remain after the transaction.

II. EXEMPTION NOTICE

Under North Carolina law, a CON is required prior to offering or developing a "new institutional health service." A "[n]ew institutional health service" includes a variety of services and activities, including the establishment of a hospital.¹ However, the North Carolina General Assembly has exempted certain types of proposals from CON review under N.C. Gen. Stat. § 131E-184, including the acquisition of an existing health service facility, including equipment owned at the time of acquisition.²

In this transaction, Mr. Trefzger will be acquiring 80.7692% of the membership interests of an existing "health service facility" to become its sole member. Even if viewed as an acquisition of AHI, the proposed transaction does not entail the purchase of any major medical equipment or any *per se* reviewable equipment as defined in N.C. Gen. Stat. §§ 131E-176(14)(o) and (16)(f1) except in conjunction with the acquisition of the entire health care facility.

Thus, given that the transaction involves only the acquisition of the membership interests of AHI, in our view it is neither subject to CON review nor does it require an exemption from CON review under N.C. Gen. Stat. § 131E-184. Nonetheless, should the Section disagree, this letter is intended to constitute notice to the Section under N.C. Gen. Stat. § 131E-184 of an exempt transaction. Based on the foregoing information, we hereby request the Agency's confirmation that the transaction described above is not subject to review or is exempt from CON review under N.C. Gen. Stat. §131E-184(a)(8).
