Dear Mr. Hance:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your letter of September 3, 2015, the above referenced proposal is exempt from certificate of need review in accordance with G.S. 131E-184(a)(8). Therefore, NC Pace RE, LLC may proceed to acquire the above referenced health service facilities without first obtaining a certificate of need. However, you need to contact the Agency's Mental Health Section to obtain instructions for changing ownership of the existing facilities. Note that pursuant to G.S. 131E-181(b): *"A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."*

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. This is to notify you of the proposed change of ownership of the Intermediate Care Facilities (ICFs) listed in Attachment A (the "ICF Facilities") and the additional facilities listed in Attachment B (the "Non-ICF Facilities") (collectively, the "Facilities"). The change of ownership is scheduled to occur on or about October 1, 2015.

The new operator of the Facilities will be RHA Health Services NC, LLC. The new real estate owner of the ICF Facilities will be NC Pace RE, LLC.
