Dear Mr. Leandro:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of February 19, 2016 and received on February 24, 3016, the above referenced proposal is exempt from certificate of need review in accordance with G.S 131E-184(e). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Adult Care Licensure Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate;



(3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.



This letter is intended to provide notice to the Certificate of Need Section ("CON") that Sandy Ridge Assisted Living ("Sandy Ridge") (HAL-062-009) is planning to expand upon its existing site, which is located at 326 Bowman Road, Candor, NC 27229.

Sandy Ridge currently has 104 licensed adult care home beds. Many of these beds are currently utilized as semi-private rooms. Sandy Ridge intends to construct additional rooms at the facility so that it can convert some of the semiprivate resident rooms into private rooms. See attached Construction Drawing. This addition to the facility will not result in any additional licensed beds and the facility will remain licensed to serve 104 residents. Under N.C. Gen. Stat. § 131E-184(e) this type of addition is exempt from CON review.


