The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your email of September 7, 2016, the above referenced proposal is exempt from certificate of need review in accordance with G.S 131E-184(a)(8). Therefore, you may proceed to acquire the above referenced health service facility without first obtaining a certificate of need.
