Dear Ms. Gunter:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your letter of August 29, 2016, the above referenced proposal is exempt from certificate of need review in accordance with G.S 131E-184(a)(8). Therefore, the entities identified in Attachment A may proceed to acquire the above referenced health service facilities without first obtaining a certificate of need. However, you need to contact the Agency's Nursing Home Licensure and Certification Section to obtain instructions for changing ownership of the existing facilities. Note that pursuant to G.S. 131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Re: Internal Reorganization of PruittHealth's North Carolina Skilled Nursing Facilities

Dear Martha:

Pursuant to N.C. Gen. Stat. § 131E-184(a)(8), this letter serves as prior written notice of an internal reorganization of the PruittHealth organization's skilled nursing facilities (SNFs) in North Carolina listed on the attached Exhibit A. Specifically, each current CON holder listed on Exhibit A intends to transfer the CON rights to various property holding companies, which are all ultimately owned by the same parent company, United Health Services, Inc. No third parties outside the PruittHealth organization are involved in this internal reorganization. The licensed operators of these SNFs will not change as a result of this reorganization and the operations of these SNFs will otherwise remain unchanged. The licensed operators will continue to lease the facilities from the property companies as they do now. As Exhibit A shows, some of these facilities were built before the CON Law. In some cases, two entities (an operating company and a property company) applied for the CON together; in those cases, the effect of this transfer would be to make the property company the sole owner of the CON.

This internal reorganization of the PruittHealth organization's SNFs does not implicate any of the definitions of "new institutional health service" under the CON Law. In particular, no new beds, equipment or other healthcare services are being added.

Accordingly, PruittHealth respectfully requests that the CON Section issue a written determination that the reorganization is exempt from CON review.
