#### Dear Ms. Kirkman:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of April 3, 2017, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. § 131E-184(a)(4). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure & Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

RE: Exemption Request for The Charlotte-Mecklenburg Hospital Authority d/b/a Carolinas Medical Center-Mercy("CMC-Mercy") to complete an infrastructure repair/upgrade to exterior of the building

Dear Ms. Frisone:

This letter serves as notification of CMC-Mercy's intent to repair and replace where necessary veneer on the exterior of the building. Deterioration because of water infiltration has caused supporting structural steel to delaminate, rust and deflect, indicating imminent failure. Pursuant to N.C.G.S. 131 E-184 (a)(1), this project is exempt from certificate of need review.

CMC-Mercy intends to replace and/or repair the veneer on the stair towers in three locations on the main campus. Construction will consist of de-cladding of veneer and its structural components. A water-tight system will be installed and the new veneer will be a drainable EIFS System with the associated structural components. Smaller areas will have structural repairs to the veneer.

The estimated capital cost of this project is \$3,950,000.
