The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of April 7, 2017, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(7). Therefore, you may proceed to modify without a certificate of need the vascular lab equipment to perform cardiac catheterization procedures on a temporary basis while the cardiac catheterization equipment is being repaired.



Dear Ms. Frisone:

We submit this notice on behalf of WakeMed regarding the temporary replacement of the existing cardiac catheterization lab located at WakeMed Cary Hospital in Cary, Wake County, North Carolina ("Cath Lab"). The pertinent facts supporting this request are outlined below.

WakeMed operates and holds a certificate of need for one cardiac catheterization lab at WakeMed Cary. This morning, the Cath Lab experienced a malfunction that took the machine out of service and which will a require replacement of parts estimated to take two to three weeks. Without provision for temporary cardiac catheterization service, patients at WakeMed Cary (including inpatients) who require cardiac catheterization procedures would require transfer to another facility.

However, WakeMed Cary has a vascular lab that can be converted via a software modification that would allow it to perform cardiac catheterization procedures while the Cath Lab is being repaired. Accordingly, WakeMed plans to modify its vascular lab and use it to temporarily replace the Cath Lab. Once the Cath Lab is repaired, it will be returned to service and it will replace the modified vascular lab. When the Cath Lab is returned to service, the software modification to the vascular lab will be reversed and it will resume service as a vascular lab only.

Neither the software modification nor either replacement will require any capital expenditure, and WakeMed Cary will not at any time operate more than one cardiac

catheterization lab. Further, the replacement of the Cath Lab will have no effect on patient charges or operating expenses, consistent with 10A N.C.A.C. 14C.0303(d)(3). Accordingly, the replacement of Unit S1336M with Unit G1251A is exempt from review under N.C. Gen. Stat. § 131E-184(a)(7).

As set forth above, we request the Agency's confirmation that the temporary replacement of the Cath Lab, and the subsequent replacement of the temporary equipment with the Cath Lab once it is repaired, are exempt from CON review pursuant to N.C. Gen. Stat. § 131E-184(a)(7) and do not require CON review or approval.
