Dear Ms. Harris:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your letter of February 1, 2017, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(8). Therefore, Morningside of Concord, LLC may proceed to acquire the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Agency's Adult Care Licensure Section to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C. Gen. Stat. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. ## Dear Martha:

This letter is to provide prior written notice, pursuant to N.C. Gen. Stat. § 131E-184(a)(8), that Five Star Quality Care – OBX Owner, LLC plans to transfer ownership of the property and existing, licensed adult care home located at 11230 Ballantyne Trace Court, Charlotte, Mecklenburg County, North Carolina 28277 (the "Facility") to Morningside of Concord, LLC, a Delaware limited liability company. This transfer is part of an internal reorganization and refinancing transaction by Five Star Quality Care, Inc., a Maryland corporation ("Five Star"). Five Star is a NASDAQ listed company that owns and operates senior living facilities in a number of states through its wholly-owned subsidiaries. Both Five Star Quality Care – OBX Owner, LLC, and Morningside of Concord, LLC are subsidiaries of Five Star.

The Facility is currently leased and operated by Five Star Quality Care – OBX Operator, LLC, which conducts business under the name of Legacy Heights Senior Living Community (the "Licensee"). The Facility is licensed by the North Carolina Department of Health and Human Services, Division of Health Service Regulation as an adult care home with 122 beds under license number HAL-060-097. See Exhibit A for a copy of the Facility's current license. After the closing of the transaction, Morningside of Concord, LLC will own and operate the Facility. The transaction does not involve any changes in the number of beds or the services being provided at the Facility.

Because this transaction is scheduled to close in late February, we would appreciate receiving your confirmation as soon as possible that the acquisition described above is exempt from certificate of need review pursuant to N.C. Gen. Stat. § 131E-184(a)(8). We appreciate your consideration of and attention to this request.
