Dear Ms. Bordelon:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) received your letter of January 12, 2017 regarding the above referenced proposal. Based on the CON law **in effect on the date of this response to your request**, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

However, you need to contact the Agency's Acute and Home Care Licensure and Certification Section to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented in your correspondence. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by this office. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the


original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Cape Fear Valley HomeCare and Hospice, LLC d/b/a Cape Fear Valley Hospice and Palliative Care anticipates relocating its administrative office effective February 7, 2017 to 3400 Walsh Parkway, Suite 100, Fayetteville, NC 28311-1642, which is in the same county as the current address. The current office address for the provider is 1830 Owen Drive, Suite 203, Fayetteville, NC 28304-3412, and the approximate distance between the two sites is less than two and one-half miles.

The relocation is being made pursuant to an operational lease for new space, which will involve the relocation of all of Cape Fear Valley Hospice and Palliative Care's administrative personnel, related office furniture, records and computer systems; in addition, the associated capital expenses will remain below the certificate of need expenditure thresholds. No additional or expanded services will be offered at the new office location and there will be no changes in the staff, management and service area. The phone and fax number will remain the same and the move will not include the addition or conversion of any beds, nor will it involve the acquisition of stock.
