RE: Exemption Request for Physician Office Building in Pineville, North Carolina (Mecklenburg County)

Dear Ms. Frisone:

Mercy Health Services, Inc., wholly owned by The Charlotte-Mecklenburg Hospital Authority, is planning to construct and operate a 149,000 square foot physician office building located at 10660 Park Road, Pineville, NC (Pineville Medical Plaza II). There will be no new institutional health services offered or developed in the new building without first obtaining the necessary certificate of need approval. The estimated cost of the medical office building is \$24,335,000.

In addition, Mercy Health Services, Inc. proposes to expand the existing parking deck located adjacent to the proposed medical office building. The expansion will add 314 parking spaces and the estimated cost is \$6,200,000.

Based upon the project as described above and pursuant to N.C.G.S. § 131E-184(a)(9) and N.C.G.S. § 131E-184(a)(4) this project is exempt from CON review. This letter serves as notification of our intent to proceed with this project. We would appreciate your written concurrence that this project is exempt from CON review.
