Medical Office Building Exemption Request

Dear Ms. Frisone:

Cape Fear Valley Health System proposes to build a new medical office building to replace our Hoke Family Medical Clinic currently located on 405 South Main Street, Raeford, NC. The new facility will be adjacent to the current structure, once completed the current structure will be demolished. The Clinic will be approximately 5,600 square feet and will include primary care clinic services. The proposed MOB does not include any new institutional health services (NIHS). If in the future CFVHS decides to develop a NIHS in the MOB, CFVHS will apply for a Certificate of Need and all costs associated with the NIHS will be reflected as required.

CFVHS requests a determination that construction of the proposed medical office building is exempt from CON review in accordance with North Carolina G.S. 131E-184(1)(9). As previously stated, CFVHS will pursue a Certificate of Need for any NIHS developed in the building in the future.
