Dear Ms. Zerman:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of April 2, 2018, the above referenced proposal is exempt from certificate of need review in accordance with Gen. Stat. §131E-184(a)(4). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure and Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

I am writing on behalf of the Health System Properties LLC. Health System Properties LLC is planning to develop a parking deck to be located at 300 Eastowne Drive, Chapel Hill, NC. The parking deck will house approximately 580 parking stalls. The parking is required to support staff and patients at the Eastowne locations.

Health System Properties LLC is requesting confirmation that the development of the parking deck is exempt from review pursuant to G.S. 131E-184(a)(4). G.S. 131E-184(a)(4) allows for the CON Section to exempt the development of parking, regardless of cost, unless these activities are integral portions of a project that involves the construction of a new health service facility or portion thereof and that is subject to certificate of need review. No new institutional health services will be offered at this site without a prior certificate of need application.
