Dear Ms. Crowley:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your letter August 14, 2018, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(8). Therefore, Health View Home Health & Hospice, LLC may proceed to acquire the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Agency's Acute and Home Care Licensure and Certification Section, DHSR to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C. Gen. Stat. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Dear Ms. Frisone:

The purpose of this letter is to inform you of a proposed transaction involving the acquisition of Nash County Home Health Agency ("Nash County Home Health") by HealthView Home Health & Hospice, LLC ("HealthView"). We are requesting that the North Carolina Department of Health and Human Services, Division of Health Service Regulation, Health Planning and Certificate of Need Section (the "Agency") confirm that this transaction is exempt from review pursuant to N.C. Gen. Stat. § 131E-184(a)(8).

The General Assembly has chosen to exempt certain, otherwise reviewable events from Certificate of Need ("CON") review, including the acquisition of a health service facility, along with the equipment owned by the health service facility at the time of the acquisition. See N.C. Gen. Stat. § 131E-184(a)(8). Under N.C. Gen. Stat. § 131E-176(9b), a home health agency office is a "health service facility." HealthView will be acquiring Nash County Home Health as an existing "health service facility." After the acquisition, HealthView will continue to operate the health service facility as a home health agency. Since the transaction involves only an existing health service facility, it is exempt from CON review.
