Dear Ms. Weaver:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your letters of January 17, 2018 and January 23, 2018, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(8). Therefore, Classic Care of Smithfield, LLC, may proceed to acquire the above referenced health service facilities without first obtaining a certificate of need. However, you need to contact the Agency's Adult Care Licensure Section, DHSR to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C. Gen. Stat. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. My name is Alaina Weaver and I ,along with my business partner Brenda Braswell, currently own and operate a 12 bed facility (Progressive Care in Princeton, NC) and a small family care home (Hester's Family Care in Princeton NC). We have recently spoken with the owners and administrator of Classic Care Homes, INC in Smithfield NC, which are 3, 12 bed facilities known as Classic Care Homes, Classic Care Homes 103, and Classic Care Homes 105. They stated they were interested in selling due to age and we have negotiated a price and have reached an agreement. We have spoken with our local county social worker, and she directed us to the change of ownership application on DHSR website. After reading the steps for completing a change of ownership, we then spoke with Celia in the CON office and she informed us that we needed to send you an email stating what we were planning to do. The plan is to purchase all three homes including buildings and property and transferring the license to our new name which will be Classic Care of Smithfield, LLC. We would like to keep the homes as 3 individually licensed 12 bed facilities. We are not increasing capacity, adding and special care beds, nor are we making any construction changes. Celia stated that we would need some form of letter from you in order to move forward with our project. We met with our attorneys today and they advised us that we needed

to make sure we have the go ahead from the state that we can transfer the license before we purchase. If there is any additional information you need from us please let us know.
