Dear Mr. Foster:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your correspondence of July 18, 2018 and July 23, 2018, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(8). Therefore, GAHC3 Mint Hill NC ALF, LP may proceed to acquire the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Agency's Adult Care Home Licensure Section to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C. Gen. Stat. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Good morning, Mr. Foster:

I'm in receipt of your request for a no review determination regarding the proposed transaction involving a change of ownership for the real estate for Carillon Assisted Living of Mint Hill. I need two additional pieces of information from you before I can respond:

- 1. The purpose of this letter is to request a "No Review" letter for the change of real estate owner for Carillon Assisted Living of Mint Hill (the "Facility"), an adult care home located at 5601 Margaret Wallace Road, Matthews, NC 28105 (the "Transaction"). The change of real estate owner is scheduled to occur on or after August 1, 2018. The change will not affect the operator of the Facility (the "Operator"), which will remain the same following the transaction. The Operator will continue to exist and the federal tax identification number of the Operator will not change.
