RE: Exemption Request for Physician Office Building in Charlotte, North Carolina (Mecklenburg County)

Dear Ms. Frisone:

The Charlotte-Mecklenburg Hospital Authority d/b/a Atrium Health (formerly Carolinas HealthCare System) is planning to upfit and operate a 192,000 square foot physician office building located at the intersection of Kenilworth Avenue and Harding Place, just north of Morehead Street, Charlotte, NC. A third party developer is constructing the building and the associated parking (81,000 square feet of underground parking). There will be no new institutional health services offered or developed in the new building without first obtaining the necessary certificate of need approval. The estimated cost of the upfit of the medical office building is \$48,000,000.

Based upon the project as described above and pursuant to N.C.G.S. § 131E-184(a)(9) this project is exempt from CON review.
