Dear Mr. Foster:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) received your letter of May 22, 2018 regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

However, you need to contact the Agency's Acute and Home Care Licensure and Certification Section to determine if they have any requirements.

It should be noted that this determination is binding only for the facts represented in your correspondence. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by this office. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Re: Request for No Review: North Carolina Hospice Agencies / Changes in Indirect Ownership Interest

Dear Ms. Frisone:

We are writing on behalf of CH Services Group Holdings, Inc. and its subsidiaries ("Curo") to notify you of a proposed transaction (the "Transaction") that will result in a change in indirect ownership interests of the hospice operators listed on Attachment A (the "Operators").

The Transaction will cause a change in indirect ownership interests multiple levels above the Operators. Under the Transaction, a consortium comprised of TPG Capital ("TPG"), Welsh, Carson, Anderson & Stowe ("WCAS"), Humana Inc. ("Humana") and certain other minority investors (collectively the "Shareholder Group") will acquire control of CH Services Group Holdings, Inc. The Transaction is expected to close in July 2018. We will provide you with written notice confirming the date of the closing promptly following the closing of the Transaction. The Transaction is reflected in the diagrams enclosed in Attachments B and C.

These changes are not expected to affect the Certificate of Need held by each of the Operators. In addition, there will be no change to the provision of hospice services by the Operators. As noted above, the proposed Transaction is occurring multiple levels above the Operators in the corporate organization and there will be no change to the Operators as the licensees or Medicare/Medicaid providers. The Operators will continue to exist, their current Medicare/Medicaid provider agreements will remain in place, and their federal tax identification numbers will not change. In addition, other than changes resulting in the ordinary course of business, there is no intention to change the services provided by the



Operators or their services areas, and none of the agencies' day-to-day operations should be impacted.

We are also writing to explain how the Transaction may be impacted by a separate, pending acquisition of Kindred Healthcare Inc. ("Kindred") by the Shareholder Group (the "Kindred Acquisition"), because it may impact the ultimate post-closing organizational structure of the Operators. As you may know, the Shareholder Group announced in December 2017, that it is acquiring all outstanding stock of Kindred through a separate transaction. Once the Kindred Acquisition is complete, the Shareholder Group plans to integrate the organizational structure of Curo with Kindred's existing organizational structure. The integration will in no way change the Shareholder Group's ultimate ownership interest in the Operators as proposed. The only changes will be of certain intermediate entities in the proposed organizational structures, as reflected on Attachment D. In addition, we will provide your office with notice of the final organizational structure with complete and accurate information on all new indirect ownership interests promptly after the closing of the Transaction.

Based on our April 30, 2018, telephone conversation, we understand that, because the Transaction as described above would not constitute a change in any of the Operators, the Transaction does <u>not</u> require Certificate of Need review. We also understand that the proposed Transaction or any other changes in the organizational structure multiple levels above the Operators, and including any integration after to the Kindred Acquisition, would also not require any additional notices or filings prior to the changes taking place. We also understand that the Operators' existing certificates of need will not be impacted by such changes, and that we may proceed as scheduled.

We request that your office provide a letter confirming our understanding as outlined above (i.e., a "No Review" letter). We will notify your office after the Transaction closes.

In a separate communication, change-of-information CMS-855As will be submitted to the assigned Medicare Administrative Contractor and, where required, the applicable state Medicaid agency to report this change.




