Dear Ms. Frisone and Ms. Pittman:

We represent Blue Ridge Healthcare Hospitals, Inc. d/b/a Carolinas Healthcare System Blue Ridge ("Blue Ridge"). Blue Ridge plans to acquire a medical office building located on Highway 321 at 2134 14th Ave Cir NW, Hickory, NC 28601 in Burke County from the current owner, D&H Real Estate, LLC ("D&H"). Blue Ridge has for some time and currently leases space in the medical office building from D&H to operate a hospital based pain treatment and management clinic and space that is subleased to Blue Ridge Radiology, a medical group affiliated with Blue Ridge, to operate its freestanding radiology center and practice. D&H is interested in selling the medical office building to Blue Ridge and Blue Ridge is interested in the opportunity to reduce the future cost of operating the space and accomplish more control over use of the space by becoming the owner of the medical office building. Blue Ridge will not be developing any new institutional health service as part of the acquisition.

Development or acquisition of a medical office building is exempt from certificate of need review under N.C.G.S. §131E-184(a)(9), regardless of cost, provided prior written notice is given to the Healthcare Planning and Certificate of Need Section. The pain treatment and management clinic and Blue Ridge Radiology's radiology center and practice will remain in the medical office building and no changes to their services are contemplated as part of this proposed acquisition.
