I am writing to inform you of the proposed upfit of space to be leased by the Duke University Health System in an office building located on Tower Boulevard in Durham, at a cost that is projected to exceed \$2 million (which cost will be shared by Duke and the landlord). No other new institutional health services will be offered at this site without a prior certificate of need application.
