## Dear Ms. Kirkman:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of April 18, 2018, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(a)(4). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure and Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

RE: Exemption Request for The Charlotte-Mecklenburg Hospital Authority d/b/a Carolinas Medical Center to complete infrastructure upgrades to elevators and replace two electrical switchgear panels

Dear Ms. Frisone:

This letter serves as notification of The Charlotte-Mecklenburg Hospital Authority d/b/a Carolinas Medical Center's (CMC) intent to complete an upgrade to its elevator system and replace two electrical switchgear panels. Pursuant to N.C.G.S. 131 E-184 (a)(4), these projects are exempt from certificate of need review.

CMC intends to replace twelve elevator machines located in the penthouse of the main facility building. Included in this project, CMC will:

- Reclad each of the elevator openings (132 in total; 12 elevators /11 floors)
- Renovate each of the cab interiors
- Patch and repair the elevator shafts
- Add smoke control devices and doors to bring the elevator lobbies up to current building code requirement
- Update the aesthetics in the elevator lobbies on each floor (11 floors)

The estimated capital cost of the replacement elevator project is \$6,000,0000.

CMC also intends to replace and relocate two electrical switchgear panels which serve G, H, K and L wings of the medical center. The estimated capital cost of this project is \$10,000,000.

Based upon the project as described above and pursuant to N.C.G.S. 131E-184(a)(4), this letter serves as notification of our intent to proceed with these upgrades. We would appreciate your written concurrence that these projects are exempt from certificate of need review.
