The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of April 24, 2018, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(g). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure and Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Dear Ms. Rhoe-Jones:

Pitt County Memorial Hospital, Inc. d/b/a/ Vidant Medical Center (VMC) plans to renovate its existing main GI suite to a) provide a better care environment for patients and families, b) improve clinical efficiency and cost effectiveness and c) increase the size of GI endoscopy rooms to accommodate the size of today's technology.

Today, VMC has four licensed GI endoscopy suites in the hospital. One is located in the Children's Hospital, another is located in a decommissioned operating room in the main OR suite, and the remaining two are located in the main GI suite. The main GI suite consists of the aforementioned two endoscopy rooms, a bronchoscopy lab, two separate pre-procedure patient prep and holding area, and a separate post procedure recovery unit. The suite is not optimal because:

- The separate and distinct pre and post procedure areas is not clinically efficient from a staffing, shared support, and economies of scale perspective.
- The separate and distinct areas are confusing to patients and waiting family members and requires patients and their families to constantly move from area to area. This impacts patient and family satisfaction and reduces the ability to maintain patient privacy.
- The size of the existing endoscopy room themselves are too small to support today's technology requirements, especially for more complex GI procedures like ERPCs that have to be performed in the hospital setting rather than an outpatient clinic. Today, when these procedures are performed in the main GI, equipment has to be taken in and out of the room (decreases efficiency) and when in the room, clinical personnel do not have adequate space to move freely around the room (impacts patient safety).
- Like the GI endoscopy rooms, the existing bronchoscopy lab is too small to accommodate today's technology and also doesn't allow clinical personnel to move about freely, impacting clinical efficiency and patient safety.

To address these issues among others, VMC is proposing to renovate its existing main GI suite to create a space that improves clinical efficiency, patient safety, patient and family satisfaction, and allows for the efficient adoption of today's technology.

Specifically, the project will consist of:

- Combining the separate and distinct pre and post procedure areas into one combined prep/recovery area.
- Enlarge the existing bronchoscopy lab
- Enlarge one of the existing GI labs (the other will remain in its current location)
- Reference all site and floor plans associated with the proposed project that are attached to this letter.

The project is expected to be completed by October 2020. The total capital cost of the proposed project is estimated at \$5,710,500, with \$4,402,000 in design and construction costs, \$839,000 in equipment and furniture costs, and \$469,000 in other cost related to IS, security, biomed and signage. Reference the capital cost sheet and equipment list attached to this letter.

Even though the project exceeds \$2,000,000, VMC believes that the proposed project is not subject to review under North Carolina's Certificate of Need (CON) laws. VMC's proposed project meets the requirements found in G.S. 131E-184(g). This statute states:

- (g) The Department shall exempt from certificate of need review any capital expenditure that exceeds the two million dollar (\$2,000,000) threshold set forth in G.S. 131E-176(16)b. if all of the following conditions are met:
 - (1) The sole purpose of the capital expenditure is to renovate, replace on the same site, or expand the entirety or a portion of an existing health service facility that is located on the main campus.
 - (2) The capital expenditure does not result in (i) a change in bed capacity as defined in G.S. 131E-176(5) or (ii) the addition of a health service facility or any other new institutional health service facility or any other new institutional health service other than that allowed in G.S. 131E-176(16)b.
 - (3) The licensed health service facility proposing to incur the capital expenditure shall provide prior written notice to the Department along with supporting documentation to demonstrate that it meets the exemption criteria of this subsection.

Specifically:

- a) VMC is an existing health service facility. Reference a copy of the hospital's current license attached to this letter.
- b) The sole purpose of the capital expenditure is to renovate existing space in an existing health facility for an existing health service that is located on the main campus. Reference the attached site plans that show the will occur in the same location within the hospital as it currently resides. Also reference the attached letter from Brian Floyd, President of VMC, certifying financial and administrative control of the entire licensed health service facility is exercised at the site of the proposed renovations and construction.

- c) The project does not result in a change (increase or decrease) in bed capacity nor does the project result in the addition of any other new institutional health service facilities or services. VMC currently provides GI endoscopy services in four licensed GI endoscopy rooms as part of its normal compliment of services. Reference VMC's 2017 Hospital License Renewal Application that is attached to this letter. At the completion of the proposed project, VMC will continue to provide GI endoscopy services in four licensed GI endoscopy rooms as part of its normal compliment of services.
- d) By this letter, VMC is providing prior written notice to the Department, along with supporting documentation to demonstrate that it meets the exemption criteria of this subsection.

VMC believes its proposal meets the requirements identified above and is therefore exempt from review. Therefore, VMC requests approval of a no review status for the proposed project. If you require additional information or clarification, please contact me at (252)-847-3631.






