Dear Ms. Harris:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your representations, the above referenced proposal is exempt from certificate of need (CON) review in accordance with N.C. Gen. Stat. §131E-184(a)(8). Therefore, the above referenced business may proceed to acquire the health service facility identified above without first obtaining a CON. The Agency's determination is limited to the question of whether or not the above referenced business would have to obtain a CON if the current owners of the health service facility do in fact sell it to the business listed above. Note that pursuant to N.C. Gen. Stat. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

In the event that the business listed above does acquire the facility, you should contact the Agency's Acute and Home Care Licensure and Certification Section to obtain instructions for changing ownership of the existing facility.

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a

This letter provides prior written notice, pursuant to N.C. Gen. Stat. § 131E-184(a)(8), that Scotland Memorial Hospital plans to acquire Hospice of Scotland County d/b/a Scotland Regional Hospice, an existing licensed hospice provider. At the current time, Scotland Health Care System is the sole shareholder of Hospice of Scotland County. Scotland Health Care System is also the parent entity of Scotland Memorial Hospital. Scotland Memorial Hospital plans to acquire Scotland Health Care System's ownership interest in Hospice of Scotland County as soon as possible. The name, licensure, and leadership of Hospice of Scotland County will not change as a result of this transaction.

Hospice of Scotland County is licensed to provide home care services, hospice home services, six hospice residential beds, and six hospice inpatient beds. This acquisition of "an existing health service facility" is exempt from certificate of need review pursuant to N.C. Gen. Stat. § 131E-184(a)(8) because, as you know, "health service facility" is defined to include a "hospice office, hospice inpatient facility, hospice residential care facility." N.C. Gen. Stat. § 131E-176(9b).

We would appreciate receiving confirmation as soon as possible that Scotland Memorial Hospital's acquisition described above is exempt from certificate of need review pursuant to N.C. Gen. Stat. § 131E-184(a)(8). We appreciate your consideration of and prompt attention to this request. If you have any questions or need additional information, please do not hesitate to contact me.
