### Dear Ms. Hollender:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) received your letter of October 11, 2018 regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

However, you need to contact the Agency's Acute and Home Care Licensure and Certification Section to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented in your correspondence. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by this office. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Dear Ms. Frisone,

We are writing this letter to you on behalf of Bayada Home Health Care, Inc. ("Bayada") to notify you of an internal corporate restructure that Bayada is undergoing on December 31, 2018 which will result in a change to the indirect ownership interests at the parent level of Bayada. We request that your office provide a letter confirming our understanding as outlined below (i.e. a "No Review" letter). We really appreciate your time and assistance with this process.

Bayada maintains the North Carolina certificates of need ("<u>CON</u>") listed in <u>Attachment A.</u> For your reference, <u>Attachment B</u> lists all licensed locations of Bayada in North Carolina with each facility's address and county.

### I. Structure of The Transaction

As detailed below, Bayada plans to undergo an internal restructure designed to allow Mr. Joseph Mark Baiada, the sole, current owner of Bayada, to gift all of his interest in Bayada to a 501(c)(3) non-profit corporation. This transaction is designed to enable Bayada to continue in perpetuity to deliver care to its patients.

Under the transaction's structure, illustrated in the attached organizational chart in Attachment C, there are two steps.

1. In the first step, on December 3, 2018, Mr. Baiada will transfer 100% of his equity in Bayada to Bayada Newco, LLC, a newly formed entity of which he will be sole indirect owner.

2. In the second step, on December 31, 2018, Mr. Baiada will gift 100% of his interest in Bayada Newco, LLC to a newly formed 501(c)(3) non-profit corporation. The non-profit corporation will be the "grandparent" entity of Bayada.

The 501(c)(3) non-profit corporation will be run by a board of directors whose members have expertise and experience in the provision of home health services or issues that are relevant to the provision of health care services.

During the restructuring, Bayada will convert from a corporation to a limited liability company on December 18, 2018, and then back to a corporation on December 31, 2018, but its federal tax identification number and national provider identifier ("NPI") will remain the same throughout the transaction.

No real estate or money will change hands during the transaction. Instead, Mr. Baiada is gifting all of his interest in Bayada to the 501(c)(3) non-profit corporation without compensation from any individual or entity.

We obtained verification from Nancy Joyce, Administrative Officer for the North Carolina Department of Health and Human Services, Division of Health Services Regulation, that the transaction will not be considered a change of ownership for purposes of the state licenses and that the transaction will not impact Bayada's state licenses. Additionally, Medicare does not consider this transaction to be a change of ownership. Further, North Carolina Medicaid does not consider this transaction to be a change of ownership.

### II. No Impact on CON

This transaction is not expected to affect the CONs held by Baydaa. Specifically, there will be no change to Bayada's provision of services. After the transaction is complete, the same nurses, attendants and administrators will continue to care for Bayada's patients. Throughout the transaction, Bayada's state licenses will not be transferred to another party. Instead, Bayada will retain its state licenses after the transaction.<sup>1</sup>

As detailed above, the transaction is occurring at the "parent" and "grandparent" level above the licensed provider and there will be no change in Bayada's state licenses, Medicare certification, or Medicaid enrollment. Bayada will continue to exist, its Medicare and Medicaid provider agreements will remain in place, and its NPIs and federal tax identification number will remain the same. Additionally, Bayada has no intention to change the services it provides or the service areas that it renders services in. Further, Bayada's day to day operations should not be impacted by the transaction.

Based on our phone conference with Ms. Gloria Hale, we understand that because the transaction does not constitute a change to any of Bayda's licensed entities that hold a North Carolina CON, the transaction should not trigger a CON review. We understand that the transaction or any other changes in the organizational structure above the licensed entity do not

require additional notices or filings prior to the changes taking place. We also understand that Bayada's existing CONs will not be impacted by the transaction and that we may proceed with the transaction as scheduled.

We request that your office provide a letter confirming our understanding as outlined above (i.e. a "No Review" letter).

Please advise us if any further information is required. We look forward to hearing from you. Thank you for your assistance with this matter- we really appreciate your time.




### **STEP 1:**

Joseph Mark Baiada will gift 100% of his ownership of BAYADA Home Health Care, Inc. to a wholly-owned corporate entity, Bayada Newco, LLC.



### **STEP 2:**

In the second step, Joseph Mark Baiada will gift 100% of his interest in Bayada Newco, LLC to a newly formed 501(c)(3) non-profit corporation. The newly formed 501(c)(3) non-profit corporation will be the "grandparent" entity of BAYADA Home Health Care, Inc.



In the meantime, BAYADA Home Health Care, Inc. converts from an "Inc." to an "LLC," and back to an "Inc.," but its EIN will not change.
