Dear Mr. Eubanks:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) determined that based on your representations, the above referenced proposal is exempt from certificate of need (CON) review in accordance with N.C. Gen. Stat. §131E-184(a)(8). Therefore, the above referenced business may proceed to acquire the health service facility identified above without first obtaining a CON. The Agency's determination is limited to the question of whether or not the above referenced business would have to obtain a CON if the current owners of the health service facility do in fact sell it to the business listed above. Note that pursuant to N.C. Gen. Stat. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

In the event that the business listed above does acquire the facility, you should contact the Agency's Acute and Home Care Licensure and Certification Section, DHSR Section to obtain instructions for changing ownership of the existing facility.

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination regarding whether or not a certificate of need would be required. The purpose of this letter is to provide notice to the North Carolina Department of Health and Human Services, Division of Health Service Regulation ("DHSR"), Certificate of Need Section (the "CON Section") that MSA Home Health and Hospice of the Piedmont, Inc., a North Carolina corporation ("MSA-Piedmont"), which is an affiliate of Medical Services of America, Inc. will be purchasing substantially all the assets of Person County, a North Carolina political subdivision (the "County"), owned and used in connection with the operation of its licensed and Medicare-certified home health and hospice agency located in Roxboro, North Carolina, d/b/a Home Health and Hospice of Person County (License No. HC0533) (the "Roxboro Agency").

The acquisition of "an existing health service facility" is exempt from certificate of need review pursuant to N.C. Gen. Stat.§131E-184(a)(8), and as you know, "health service facility" is defined to include home health agencies as well as hospice agencies. N.C. Gen. Stat.§131E-176 (9b).

At this time we respectfully request that you please confirm that MSA-Piedmont's acquisition of the Roxboro Agency is exempt from CON review pursuant to N.C. Gen. Stat. §131E-184(a)(8).
