Dear Mr. Eads:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of September 26, 2018, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(e), based on your assertions that the project is to renovate and expand the nursing facility on the same site, converting semi-private rooms to private rooms; and it will not result in a change in bed capacity. Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Nursing Home Licensure and Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate;

Village Care of King will soon undergo a renovation/expansion project with an estimated 4 million dollar capital budget. In this project we will be adding 20 private rooms and a new rehabilitation gymnasium. The plans also include renovation of some existing rooms, converting them to private and upgrading office and common areas. There will be no change in services offered. In converting these existing rooms our bed capacity will remain the same.
