The purpose of this letter is to provide notice of the renovation of the building designated as the North Pavilion, located at 2400 Pratt Street in Durham, North Carolina, and to seek confirmation that this project is exempt from certificate of need review.

The Duke University School of Medicine is planning to renovate and expand an existing building located at 2400 Pratt Street known as North Pavilion, where it may subsequently lease space to the Duke University Health System to accommodate physician clinics and other health system services. No new institutional health services will be included in this expansion project without a prior certificate of need application. Construction plans are included. It is our understanding that this project is exempt from certificate of need review as the development of a physician office building pursuant to NCGS 131E-184(9).
