I am writing on behalf of our clients, Novant Health, Inc. and The Presbyterian Hospital ("Novant"), regarding the construction of a medical office building ("MOB") in Charlotte, Mecklenburg County. By this letter, we respectfully request the Agency's written confirmation that construction of the MOB is exempt from CON Review pursuant to N.C. Gen. Stat. § 131E-184(a)(9). Stat. § 131E-176(16)a.-v. in the building that will house the MOB, it will file a CON application to do so and will refrain from undertaking any such efforts absent CON approval.
