The Charlotte-Mecklenburg Hospital Authority is planning to construct and operate a 24,500 square foot medical office building located on the Carolinas Medical Center main campus at the corner of Kenilworth and East Morehead Street, adjacent and connected to Levine Cancer Institute. There will be no new institutional health services offered or developed in the new building without first obtaining the necessary certificate of need approval. The estimated cost of the medical office building is greater than \$2,000,000.

Based upon the project as described above and pursuant to N.C.G.S. § 131E-184(a)(9) this project is exempt from CON review.
