Dear Mr. Qualls:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) received your correspondence regarding the above referenced proposal. Based on the CON law **in effect on the date of this response to your request**, the proposal described in that correspondence is not governed by, and therefore, does not currently require a certificate of need. If the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective. This determination is based on your representations that the existing unit will be sold or otherwise disposed of and will not be used again in the State without first obtaining a certificate of need if one is required.

You may need to contact the Agency's Acute and Home Care Licensure and Certification Section to determine if they have any requirements for development of the proposed project.

This determination is binding only for the facts represented in your correspondence. If changes are made in the project or in the facts provided in the correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by this office.

Re: No Review Request for Cardiac Cath Equipment Swap Within CMC's Licensed Campuses

Dear Ms. Frisone:

My client, The Charlotte-Mecklenburg Hospital Authority ("CMHA"), d/b/a Carolinas Medical Center ("CMC") requests a no review determination that the relocation of cardiac catheterization ("cath") CON rights within CMC's licensed hospital does not require a CON.

Specifically, CMC has nine (9) Cardiac Cath Equipment<sup>1</sup> Units in its licensed hospital. Eight (8) of those Units are currently on the CMC Campus and one (1) Unit is on the CMC-Mercy Campus. Historically, CMC operated eight (8) Cardiac Cath Equipment Units on its license and Atrium Health University City (f/k/a CHS University) operated one (1) Cardiac Cath Equipment Unit on its license. However, by a September 29, 2017 Material Compliance Approval (attached as Exhibit 1), the Agency approved CMHA's request to relocate the University City Cardiac Cath Equipment Unit to CMC. CMHA has recently implemented that relocation. Therefore, CMC now operates nine (9) Cardiac Cath Equipment Units under its license.

CMC wants to house all nine Cardiac Cath Equipment Units on the CMC Campus. To do so, CMC proposes to cease using the one Unit on the CMC-Mercy Campus and start using an electrophysiology ("EP") unit as a Cardiac Cath Equipment Unit in its stead (the "Equipment Swap"). The existing CMC-Mercy Campus Cardiac Cath Equipment Unit will be disposed of.

The term "Cardiac Cath Equipment," as used in this letter, is the equipment regulated by N.C. Gen. Stat. § 131E-176(16)(f1)(3) and defined in N.C. Gen. Stat. § 131E-176(16)(2f).

We ask that the North Carolina Department of Health and Human Services, Division of Health Service Regulation, Healthcare Planning and Certificate of Need Section (the "Agency") determine that this intra-hospital "Equipment Swap" is non-reviewable because it does not constitute a new institutional health service under N.C. Gen. Stat. § 131E-176(16).

Under North Carolina law, a CON is required only prior to offering or developing a "new institutional health service." "New institutional health service[s]" include a variety of services and activities, including the acquisition of cardiac cath equipment. See N.C. Gen. Stat. § 131E-176(16)(f1)(3). However, CMHA is not acquiring Cardiac Cath Equipment here. Rather, CMHA is simply shifting which piece of existing equipment within the same licensed hospital will be used as Cardiac Cath Equipment, as regulated by Section 131E-176(16)(f1)(3) and defined in Section 131E-176(16)(2f).

The attached floor plans show where the seven (7) <u>Adult Cardiac Cath Units on the CMC Campus will be housed</u>. CMC has two (2) Pediatric Cardiac Cath Equipment Units that are not located in the same area of the building as the Adult Cardiac Cath Equipment Units. Because the Pediatric Cardiac Cath Equipment Units are not being affected by the Equipment Swap, the attached floor plans do not show these two (2) Pediatric Cardiac Cath Equipment Units.

### **Current Locations of Cardiac Cath Units on CMC License**

The current locations of CMC's licensed Cardiac Cath Equipment Units are as follows:

- One (1) Adult Cardiac Cath Equipment Unit is located on CMC Main, Level 4 (Exhibit 2 Floor Plan).
- Five (5) Adult Cardiac Cath Equipment Units are located on CMC Main, Level 6 (Exhibit 3 Floor Plan).
- Two (2) Pediatric Cardiac Cath Equipment Units are located on CMC Main, Level 6 (Not on Floor Plan).
- One (1) Cardiac Cath Equipment Unit is currently located on the CMC Mercy Campus.

### Proposed Locations of Cardiac Cath Units on CMC License

After the Equipment Swap, the proposed locations of CMC's licensed Cardiac Cath Equipment Units are as follows:

- One (1) Adult Cardiac Cath Equipment Unit is located on CMC Main, Level 4 (Exhibit 1 Floor Plan).
- Six (6) Adult Cardiac Cath Equipment Units are <u>to be</u> located on CMC Main, Level 6 (Exhibit 4 Floor Plan).
- Two (2) Pediatric Cardiac Cath Equipment Units are located on CMC Main, Level 6 (Not on Floor Plan).
- <u>No</u> Cardiac Cath Units will be located on the CMC Mercy Campus. See Disposition Letter attached as Exhibit 5.

Given that the Equipment Swap does not trigger any "new institutional health service" categories, please confirm that the Equipment Swap is not CON reviewable because it does not constitute a new institutional health service.

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) has determined that the change proposed in your letter of September 7, 2017 is in material compliance with representations made in the application. This change includes changing the site of one unit of cardiac catheterization equipment from CHS University to CMC where it will be located in Cardiology Room 8. The EP unit located in that room will become a cardiac catheterization unit. Upon completion, CHS University will have zero cardiac catheterization units and CMC will have nine cardiac catheterization units on its license. However, you should contact the Agency's Construction Section to determine if they have any requirements pertinent to the proposed change.

It should be noted that the Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this office and a separate determination.


