RE: Notice of Exemption for Physician Office Building Upfit Costs

Dear Ms. Thorne-Williams:

I am writing on behalf of UNC Physicians Network ("UNCPN"), which is planning to incur costs in connection with the upfit of approximately 10,000 square feet of space within a physician office building. The building is being developed by an unrelated third party and will be located on Pineville Boulevard in Clayton, Johnston County. UNCPN intends to lease physician office space within the building. None of the services provided in the leased space will be hospital-based services.

We are requesting confirmation that the expenditure of capital in excess of \$2 million for the upfit of leased physician office space is exempt from review pursuant to N.C.G.S. § 131E-184(a)(9). In accordance with this statutory exemption, there will be no new institutional health service other than as defined in N.C.G.S. § 131E-176(16)b. offered or developed in this space without prior certicate of need approval. Please provide written confirmation that this proposal is exempt from CON review.
