Dear Ms. Cummer:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of June 20, 2019, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(g). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure and Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Re: Exemption Notice/Duke Raleigh Hospital

Dear Ms. Frisone and Mr. McKillip:

The purpose of this letter is to provide notice of two renovation projects at Duke Raleigh Hospital and to request confirmation that this project is exempt from certificate of need review. Duke plans to renovate portions of Medical Office Building 9 on the hospital campus (in which certain hospital services are offered and/or in the process of being developed) in two separate projects that may each exceed two million dollars:

- 1) The creation of basement level patient and staff entrance and the improvement of patient parking. The project includes landscaping, grading, and altering the building at the basement level to create an accommodating entrance, along with a few additional level, disabled parking spaces in close proximity to the building. The northern patient entrance for MOB 9 has limited parking spaces in close proximity to the building and the grade is not level. The southern entrance has parking spaces closer to the entrance, but is only accessible after climbing three sets of stairs. This project would improve these access issues by removing the stairs and landscaping on the southern portion of the building, regrading parts of the parcel next to the building, and creating a new building entrance at the basement level. Inside the building, a new lobby would be created for patients and guests. Construction plans for this project are enclosed.
- 2) The replacement of the curtain wall system and windows. A curtain wall system is an outer covering of a building that protects the interior of a building from environmental elements and creates a safe and comfortable working environment for occupants. The curtain wall system is designed to absorb sway induced by wind and seismic forces acting on the building. The age of MOB 9 and a lack of maintenance prior to Duke's ownership has caused the current curtain wall system to leak. This project will extend

the useful life of the building and will also improve the energy efficiency and overall aesthetics of the building.

We understand that these projects are exempt from certificate of need review pursuant to G.S. 131E-184(g). These projects will each "renovate, replace on the same site, or expand the entirety or a portion of an existing health service facility that is located on the main campus," defined in 131E-176(14n) as "[t]he site of the main building from which a licensed health service facility provides clinical patient services and exercises financial and administrative control over the entire facility, including the buildings and grounds adjacent to that main building" and "[o]ther areas and structures that are not strictly contiguous to the main building but are located within 250 yards of the main building." The building from which Duke Raleigh Hospital, a licensed acute care hospital, provides clinical patient services and exercises financial and administrative control over the entire facility is the main hospital building located at 3400 Wake Forest Road, and is within 250 yards of MOB 9. These projects do not relate to any change in licensed bed capacity or the addition of any health service facility or new institutional health services other than that allowed in GS 131E-176(b).

Alternatively, the projects may also be exempt pursuant to G.S. 131E-184(a)(4), which exempts projects "[t]o provide parking, heating or cooling systems, elevators, or other basic plant or mechanical improvements...."


