Dear Ms. Cummer:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of March 1, 2019, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(4). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Acute and Home Care Licensure and Certification Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Dear Ms. Frisone and Ms. Thorne-Williams:

On behalf of the Duke University Health System, I am writing to notify you of a project proposed by Duke Regional Hospital in Durham ("DRH") and to request the Section's written confirmation that this project is exempt from certificate of need review.

DRH proposes to spend more than \$2 million to replace, expand, and/or refurbish two air handling systems (#N1 and #7). These systems provide conditioned air and ventilation to both patient care areas, including the Emergency Department (ED) and Catheterization Laboratory, and non-patient care areas. While various components of these systems have been replaced over the years, they are beyond their normal life expectancy and require replacement or significant refurbishment in order to continue providing a reliable source of conditioned air and ventilation.

It is our understanding that this project is exempt from certificate of need review pursuant to Section 131E-184(4), as it is needed "[t]o provide parking, heating or cooling systems, elevators, or other basic plant or mechanical improvements, unless these activities are integral portions of a project that involves the construction of a new health service facility or portion therefor and that is subject to certificate of need review." This project is not integral to any other construction project that would otherwise require a CON. We would appreciate your review of this notice and confirmation of our understanding.
