The Charlotte-Mecklenburg Hospital Authority d/b/a Atrium Health (formerly Carolinas HealthCare System) is planning to upfit and operate a 40,000 square foot physician office building located at the intersection at the intersection of Independence Boulevard/Highway 74 and Stallings Road in Stallings, NC. There will be no new institutional health services offered or developed in the new building without first obtaining the necessary certificate of need approval. The estimated cost of the medical office building is \$13,500,000.
