Ms. Frisone and Ms. Inman:

I am writing to you pursuant to N.C.G.S. § 131E-184(a)(9) to inform you of The Moses H. Cone Memorial Hospital and Moses Cone Medical Service, Inc. d/b/a Cone Health, Cone Health Medical Group, and LeBauer Health ("Cone Health")'s plan to construct and operate a medical office building ("MOB") located at 709 Green Valley Road in Greensboro, NC. This planned MOB will house office space for physicians and other tenants. The MOB will provide a new location and improved space for physicians and patients. There will be no new institutional health services offered or developed in the new building without first obtaining the necessary certificate of need approval. The estimated cost of the MOB is greater than \$2,000,000.
