Dear Mr. Iorga:

The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that based on your letter of **April 21, 2020**, the above referenced proposal is exempt from certificate of need review in accordance with N.C. Gen. Stat. §131E-184(e). Therefore, you may proceed to offer, develop, or establish the above referenced project without a certificate of need.

However, you need to contact the Agency's Construction and Adult Care Licensure Sections to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

RE: REQUEST FOR CERTIFICATE OF NEED EXEMPTION

Renovation of existing space, resident rooms and main entrance additions

Carmel Hills Christian Retirement Community Inc. 2801 Carmel Rd. Charlotte, NC 28226

We are writing to inform you that Carmel Hills plans to renovate existing space, add a new facility mainentrance and add fourteen new (net eight) private resident rooms to our main campus at 2801 Carmel Rd. Charlotte, NC 28226. We net eight new private rooms based on seven existing rooms being utilized in the renovation to increase common area for residents and to increase facility management space.

The addition of the new resident rooms will not increase the number of licensed beds at Carmel Hills as defined in G.S. 131E-176(5) and no new Institutional Health Services will be offered as a result of this renovation and facility expansion.

We request an exemption for Certificate of Need review pursuant to *G.S. 131E-176(16)b* in connection with the proposed construction. We meet the criterion of all items 1-3 noted below for the exemption.

The Department shall exempt from certificate of need review any capital expenditure that exceeds the two million dollar (\$2,000,000) threshold set forth in G.S. 131E-176(16)b. if all of the following conditions are met:

- (1) The sole purpose of the capital expenditure is to renovate, replace on the same site, or expand the entirety or a portion of an existing health service facility that is located on the main campus.
- (2) The capital expenditure does not result in (i) a change in bed capacity as defined in G.S. 131E-176(5) or (ii) the addition of a health service facility or any other new institutional health service other than that allowed in G.S. 131E-176(16)b.
- (3) The licensed health service facility proposing to incur the capital expenditure shall provide prior written notice to the Department, along with supporting documentation to demonstrate that it meets the exemption criteria of this subsection.

We are currently licensed for thirty-eight (38) beds in our Assisted Living Department however, our current facility layout only comfortably supports thirty (30) beds.

Our proposed room addition project includes an increase in the number of rooms to support a greater number of private rooms. Currently we have ten rooms designated for private occupancy. Upon completion of the project we will have 18 rooms designated as private.

The planned renovation will upgrade the look and feel of the current main dining room in the Assisted Living Department and increase the existing square footage of the room by fifty percent. The secondary dining room will be upgraded to the new look and feel, and the square footage of this room will be increased by twenty-five percent.

During the renovation, our current resident activity room and common area will be upgraded, and the square footage will be increased by twenty percent. To enhance the quality of life here at Carmel Hills we are adding a twelve-hundred square foot outdoor courtyard, tailored specifically to the use of the residents in the Assisted Living Department. The floor space in the resident salon will be increased by ten percent and enhanced to match the new upgraded look and feel.

If any further information is needed to secure the Certificate of Need Exemption, please let me know.
