RE: Notification of Transaction and Request for "No Review" Determination

The purpose of this letter is to provide notice to the North Carolina Department of Health and Human Services Division, Division of Health Service Regulation ("DHSR"), Certificate of Need Section of the change of the indirect owner of multiple entities holding certificates of need ("CONs") in North Carolina, and to request a "no review" determination. Please see **Attachments A, B and C** for a list of each of the entities holding CONs in North Carolina.

I. THE TRANSACTION

On April 27, 2021, Humana Inc. ("Humana"), an existing owner of Kentucky Homecare Parent Inc. ("Parent"), entered into a Stock Purchase Agreement (the "Agreement") with Kentucky Homecare JV Holdings, LP ("Kentucky Holdings"), another existing owner of the Parent, to purchase all of the shares of Parent owned by Kentucky Holdings (the "Transaction"). The Transaction follows the original transaction in 2018, when Humana acquired a 40% indirect ownership in the Parent with Kentucky Holdings having the remaining 60% indirect ownership. DHSR determined for the 2018 transaction that no review was necessary. Please see related correspondence attached as **Attachment E**. Following the original transaction, certain employees of Kentucky Homecare Parent Inc. acquired a less than 2% interest in Kentucky Homecare Parent Inc. As part of the Transaction, Humana will also exercise a contractual right to acquire this interest from the employees such that Humana will own 100% of the Parent. The Transaction is anticipated to close in September 2021. Please refer to **Attachment D** for the preand post-closing organization charts.

II. FACILITIES INVOLVED IN TRANSACTION

Humana and Kentucky Holdings¹ are the ultimate parent companies of the entities holding CONs

and licenses in your state. Following the Transaction, all of the North Carolina licensed entities will continue to conduct business under their respective CONs, state licenses, Medicare/Medicaid numbers and tax identification numbers. The Transaction will not result in a change in the licensed entities' day-to-day operations, service areas, or the services provided.

III. CERTIFICATE OF NEED REVIEW NOT TRIGGERED

Pursuant to N.C. Gen. Stat. § 131E-178(b), "[n]o person shall make an acquisition by donation, lease, transfer, or comparable arrangement without first obtaining a certificate of need from the Department, if the acquisition would have been a new institutional health service if it had been made by purchase." However, given that this Transaction results in an indirect ownership change with no changes to the licensed entity, we do not believe that the transaction is subject to a CON review. Further, an acquisition of "an existing health service facility, including equipment owned by the health service facility at the time of acquisition," is exempt from certificate of need review pursuant to N.C. Gen. Stat. § 131E-184(a)(8). "Health service facility" is defined by N.C. Gen. Stat. § 131E-176(9b) to include home health and hospice agencies. Thus, even if this transaction does not qualify for a "no review" determination, we believe that the transaction is exempt from CON review because the transaction involves the acquisition of an existing health service facility. Therefore, we respectfully request your confirmation that this Transaction results in a "no review" or, in the alternative, is exempt from CON review.




NORTH CAROLINA - KINDRED HOME HEALTH AGENCIES

NORTH CAROLINA - KINDRED HOME HEALTH AGENCIES


(Post-Closing Organizational Structure)


NORTH CAROLINA - KINDRED HOSPICE AGENCIES

However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

However, you need to contact the Agency's Acute and Home Care Licensure Section to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented in your correspondence. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by this office. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

RE: Notification of Transaction and Request for "No Review" Determination
The purpose of this letter is to provide notice to the North Carolina Department of Health and
Human Services Division, Division of Health Service Regulation ("DHSR"), Certificate of Need
Section of the change of the indirect owner of multiple Kindred at Home entities holding
certificates of need ("CONs") in North Carolina, and to request a "no review" determination.

I. THE TRANSACTION

Kindred Healthcare, Inc. ("Kindred"), the ultimate parent company of the Kindred at Home entities listed in Section II, has entered into an Agreement and Plan of Merger (the "Agreement") with a group of purchasers comprising of TPG Capital ("TPG"), Welsh, Carson, Anderson & Stowe ("WCAS"), Humana Inc. and certain other minority investors, pursuant to which this group of companies would purchase all of Kindred's outstanding and issued securities. The transaction is anticipated to close during the summer of 2018.

Effective as of the closing date:

- TPG, WCAS and certain other minority investors will separate Kindred at Home from the specialty hospital operating companies and form a joint venture with Humana to own Kindred at Home under a newly-formed entity ("Kentucky Homecare Parent Inc."), including home health, hospice and community care businesses; and
- TPG, WCAS and certain other minority investors will own 100% of Kindred's specialty hospital companies, including long term acute care hospital, inpatient rehabilitation facility, and contract rehabilitation service businesses, under a newly-formed entity ("Kentucky Hospital Holdings, LLC").

II. FACILITIES INVOLVED IN TRANSACTION

Kindred is the ultimate parent company of the following entities holding CONs and licenses in your state. Following the transaction, all of the North Carolina licensed entities will continue to conduct business under their respective CONs, state licenses, and Medicare/Medicaid numbers. The transaction simply entails a change at the ultimate parent company level resulting in two entities, Kentucky Homecare Parent Inc. and Kentucky Hospital Holdings, LLC. As such, with the exception of RehabCare Group East, Inc., the entities listed in this Section will become wholly owned subsidiaries of Kentucky Homecare Parent Inc. RehabCare Group East, Inc. will become a wholly owned subsidiary of Kentucky Hospital Holdings, LLC. ¹/ This change will not result in a change in the licensed entities' day-to-day operations, tax identification numbers, service areas, or the services provided. Please refer to Attachment A for the pre- and post-closing organization charts.

III. CERTIFICATE OF NEED REVIEW NOT TRIGGERED

Pursuant to N.C. Gen. Stat. § 131E-178(b), "[n]o person shall make an acquisition by donation, lease, transfer, or comparable arrangement without first obtaining a certificate of need from the Department, if the acquisition would have been a new institutional health service if it had been made by purchase." However, given that this transaction results in an indirect ownership change with no changes to the licensed entity, we do not believe that the transaction is subject to a CON

review. Further, an acquisition of "an existing health service facility, including equipment owned by the health service facility at the time of acquisition," is exempt from certificate of need review pursuant to N.C. Gen. Stat. § 131E-184(a)(8). "Health service facility" is defined by N.C. Gen. Stat. § 131E-176(9b) to include home health and hospice agencies. Thus, even if this transaction does not qualify for a "no review" determination, we believe that the transaction is exempt from CON review because the transaction involves the acquisition of an existing health service facility. Therefore, we respectfully request your confirmation that this transaction results in a "no review" or, in the alternative, is exempt from CON review.





NORTH CAROLINA - KINDRED HOSPICES (STRUCTURE PRIOR TO TRANSACTION)





NORTH CAROLINA - KINDRED HOSPICES (STRUCTURE FOLLOWING TRANSACTION)






NORTH CAROLINA – KINDRED REHAB CENTERS (STRUCTURE PRIOR TO THE TRANSACTION)
