The intent of this email is to inform DHHS of a change of licensee that is being requested from DHHS. Currently *A1A-Assisted Living at The ARC of Benson* operates these facilities: HAL-051-066 and HAL-051-067.

Maylon and Katie McLamb (McLamb's Rest Home) were the former operators and are the <u>owners</u> of the facilities. A1A will be relinquishing their licenses as soon as Katie and Maylon McLamb are licensed for these buildings. They are in the process of submitting applications to license these facilities and operate them by April 30, 2022.

The buildings are currently licensed for 12 beds each. While under A1A's management, HAL-051-067 was operated as a Special Care Unit. Maylon and Katie

McLamb, however, <u>will not</u> operate it as a Special Care Unit. They will operate it and HAL-051-066 as Assisted Living facilities.
