Dear Ms. Mitchell:

We are providing this notice on behalf of the facilities listed in <u>Attachment A-1</u> and <u>Attachment A-2</u> (the "<u>Facilities</u>") to inform you of a change in the indirect ownership of the operator and the entity that owns the real estate for the Facilities, which is scheduled to occur on or about August 31, 2022 (the "<u>Transaction</u>").

As reflected in the enclosed diagrams at Attachment B-1 and Attachment B-2, there will be no change to the operators as the licensees, nor will there be a change in the direct ownership of the operators or real estate entities. The change in certain indirect, non-controlling owners will take place multiple levels above the operators in the corporate structure. The operators' federal tax identification number will not change and there will be no changes to the Facilities' staff, the Facilities' day-to-day operations, or the Facilities' agreements as a result of the Transaction.





Pre-Closing Organizational Chart




