Re: No Review Request by Randolph Health to Acquire a CT Scanner

Dear Ms. Mitchell:

Our firm represents Randolph Health. We are writing to notify the North Carolina Department of Health and Human Services, Division of Health Service Regulation, Healthcare Planning and Certificate of Need Section (the “**Department**”) of Randolph Health’s plan to acquire a new, 256-slice CT scanner to be located in Randolph Health’s hospital located at 364 White Oak St., Asheboro, North Carolina, License No. H0013 (the “**Hospital**”), and to request a “no review” determination for the acquisition of this equipment.

Our understanding is that CT scanners are not subject to certificate of need review unless the cost of acquiring the equipment exceeds the \$2,000,000 threshold for “Major Medical Equipment” set forth in N.C. Gen. Stat. § 131E-176(14o). The total capital expenditure for this project, inclusive of the cost of the equipment, studies, surveys, designs, plans, working drawings, specifications, construction, installation and other activities, will be \$1,365,000 which is below the statutory threshold for certificate of need review. Therefore, we respectfully request the Department’s confirmation that this transaction is not subject to certificate of need review.
